## Standard Power of Attorney

In the Matter of

vs. **Daimler AG**

for **Damages**

the law firm of ROTTER RECHTSANWÄLTE, Baierbrunner Str. 85, 81379 München

is hereby granted an unrestricted power of attorney to represent the grantor(s) of this power of attorney individually or jointly, both in court and out of court, vis-à-vis anyone, in particular vis-à-vis all courts and government agencies, as well as at all instances. At the same time all the acts already undertaken in this matter by the holders of this authority are approved.

In particular, the power of attorney shall also include

- the filing, withdrawal and limitation of appeals and remedies of all types and the waiver thereof,
- the procedure for attachment, temporary restraining orders and preliminary orders,
- enforcement proceedings and insolvency proceedings,
- entry into and revocation of settlements, the declaration and acceptance of waivers and acknowledgments,
- undertaking unilateral legal transactions such as, e.g., termination and avoidance, set-off and retention,
- undertaking the required declarations for implementation and in the context of a model case within the meaning of the Capital Investor Model Proceedings Act [KapMuG = Kapitalleger-Musterverfahrensgesetz] (for example filing a model application for declaratory judgment; also the recommendation for a model plaintiff or notification of an agreement regarding a model plaintiff),
- the right to take delivery on behalf of the grantor(s) of the power of attorney of cash or monetary value, checks, notes and other securities as well as other objects of value and documents of all kinds, as well as having the power of disposition over these items on its (their) account, and expressly in legal deposit proceedings (in particular within the meaning of § 14 of the Court Deposit Regulations),
- the filing and the withdrawal of criminal complaints, demands for prosecution and motions for civil actions incidental to criminal proceedings as well as motions to compel prosecution.

Within the context of the powers hereby granted to them the holders of this authority shall have the right to grant full or limited substitute powers of attorney.
